5 AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA 6 COUNTY FLORIDA AMENDING THE ALACHUA COUNTY CODE OF ORDINANCES 7 ADDING CHAPTER 37.5 ESTABLISHING THE SPRINGHILLS SOUTH COMMUNITY 8 DEVELOPMENT DISTRICT PURSUANT TO CHAPTER 190, FLORIDA STATUTES (2021); 9 NAMING THE DISTRICT; DESCRIBING THE EXTERNAL BOUNDARIES OF THE 10 DISTRICT: DESCRIBING THE FUNCTIONS AND POWERS OF THE DISTRICT; 11 DESIGNATING FIVE PERSONS TO SERVE AS THE INITIAL MEMBERS OF THE EXPANDED DISTRICT'S BOARD OF SUPERVISORS; ADDRESSING ORDINANCE 12 13 CONFLICTS; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN 14 EFFECTIVE DATE. 15

## WHEREAS, Yadda Property Holdings I, LLC petitioned the Alachua County Board of Commissioners (the "County") to adopt an ordinance establishing the Springhills South

19 Development District pursuant to Chapter 190, Florida Statutes; and

#### 20 WHEREAS, the Petitioner is a Florida Limited Liability Partnership, authorized to

21 conduct business in the State of Florida; and

#### 22 WHEREAS, all interested persons and affected units of general-purpose local government

- 23 were afforded an opportunity to present oral and written comments on the Petition at a duly
- 24 noticed public hearing conducted by the County on May 24<sup>th</sup>, 2022; and

WHEREAS, upon consideration of the record established at that hearing, the County determined that the statements within the Petition were true and correct, that the establishment of the District is not inconsistent with any applicable element or portion of the state comprehensive plan or the local government comprehensive plan, that the land within the District is of sufficient size, is sufficiently compact, and sufficiently contiguous to be developable as a functionally interrelated community, that the District is the best alternative

1	available for delivering community development services and facilities to the area served by
2	the District, that the services and facilities of the District will not be incompatible with the
3	capacity and uses of existing local and regional community development services and facilities,
4	and that the area to be served by the District is amenable to separate special-district
5	governance; and
6	WHEREAS, the establishment of the District will constitute a timely, efficient, effective,
7	responsive and economic way to deliver community development services in the area described in
8	the Petition.
9	
10	NOW, THEREFORE, BE IT, RESOLVED BY THE BOARD OF COUNTY
11	COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:
12	Section 1. Legislative Findings of Fact. The Board of County Commissioners of Alachua
13	County, Florida, finds and declares that all the statements set forth in the preamble of this ordinance
14	are true and correct.
15	Section 2. Authority. This ordinance is adopted in compliance with and pursuant to the
16	Uniform Community Development District Act of 1980, Chapter 190, Florida Statutes (2021).
17 18 19	Section 3. Administrative Code. Chapter 37.5, Alachua County Code, is hereby established as follows:
20	CHAPTER 37.5
21	SPRINGHILLS SOUTH COMMUNITY DEVELOPMENT DISTRICT
22 23	Sec. 37.5.1. District name.
24	
25	Alachua County, Florida, which district shall be known as the "SPRINGHILLS SOUTH
26	COMMUNITY DEVELOPMENT DISTRICT."

2	Sec. 37.5.2. External boundaries of the district.
3	The external boundaries of the district are described in Exhibit A attached hereto and
4	incorporated by reference, the overall parcel containing 113.39 acres, more or less.
5	
6	<u>Sec. 37.5.3.</u> Powers.
7	The powers of the district are as described in F.S. § 190.011, 190.012(1), , and 190.012(3). The
8	District shall not be authorized to collect or impose public improvement fee(s) ("PIF"), which for
9	purposes of this Ordinance are defined to mean "fees collected on sales transactions to pay
10	for on-site improvements and pursuant to a recorded real estate covenant;" provided,
11	however, that nothing herein shall be construed to limit the authority of the District to levy
12	and collect non-ad valorem special assessments, or other fees or costs other than PIFs,
13	pursuant to Chapter 190, Florida Statutes.
14	Sec. 37.5.4. Board of supervisors.
15	The five persons designated to serve as initial members of the district's board of
16	supervisors are as follows: Arthur Canter, Leonard Ireland, Clay Sweger, Clifton Fisher and Jake
17	Essman. All of the above-named persons are residents of the State of Florida and citizens of the
18	United States.
19	Section 4. Conflict. The terms of this Ordinance shall govern to the extent of any conflict
20	with any other County ordinance.
21	Section 5. Repealing Clause. All ordinances or parts of ordinances in conflict herewith
22	are, to the extent of the conflict, hereby repealed.
23	Section 6. Inclusion in the Code, Scrivener's Error. It is the intention of the Board of
24	County Commissioners of Alachua County, Florida, and it is hereby provided that, at such time
25	as the Regulations of Alachua County are codified, the provisions of this ordinance shall become
26	and be made part of the Administrative Code of Alachua County, Florida; that the sections of
	Springhills South CDD Ordinance

this ordinance may be renumbered or re-lettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate designation. The correction of typographical errors that do not affect the intent of the ordinance may be authorized by the County Manager or designee, without public hearing, by filing a corrected or re-codified copy of the same with the Clerk of the Circuit Court. Section 7. Modification. It is the intent of the Board of County Commissioners that the provisions of this ordinance may be modified as a result of considerations that may arise during

8 public hearings. Such modifications shall be incorporated into the final version of the ordinance9 adopted by the Board and filed by the Clerk to the Board.

Section 8. Ordinance to be Liberally Construed. This ordinance shall be liberally
 construed in order to effectively carry out the purposes hereof which are deemed not to adversely
 affect public health, safety, or welfare.

Section 9. Severability. If any section, phrase, sentence or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

17 Section 10. Effective Date. A certified copy of this ordinance shall be filed with the 18 Department of State by the Clerk of the Board of County Commissioners within ten (10) days after 19 enactment by Board of County Commissioners, and shall take effect upon filing with the 20 Department of State.


